# **Happeningz.com Privacy Policy**

This Privacy Policy is effective for all users of Happeningz.com registering on or after November 20th, 2013. Any and all updated Privacy Policies will apply to all users thereafter and as update from time to time.

This policy tells you about how Happeningz.com uses and protects personal information. For more information regarding privacy issues, please contact us directly. This Privacy Policy covers only the Happeningz.com website. It does not cover information that may be collected through software downloaded from other sites or links.

## **Scope of Policy**

This Privacy Policy describes how Happeningz.com compiles and manages personal information for services on the websites. It applies generally to the Happeningz.com website and content and other related websites where this policy appears. Some websites may be governed by separate privacy policies.

Happeningz.com endeavors to provide a consistent set of privacy practices. By accepting the Privacy Policy and the User Agreement in registration at Happeningz.com, user(s) expressly consent to the collection, storage, use and disclosure of personal information as described in this Privacy Policy. This Privacy Policy is effective upon acceptance for new users and is otherwise effective on December 1, 2013.

#### **Collection of Information**

You can browse Happeningz.com without revealing any personal information. However, upon remittance of personal information, user(s) are no longer anonymous. If you choose to provide personal information, you hereby consent to the transfer and storage of that information on servers located in the United States.

Happeningz.com may collect and store the following personal information:

- 1. email address, physical contact information, and financial information, such as credit card or bank account numbers;
- 2. transactional information based on activities on the sites;
- 3. shipping, billing and other information provided to purchase or ship an item;
- 4. community discussions, chats, dispute resolution, and correspondence;
- 5. other information from interactions with Happeningz.com sites, services, content and advertising, including computer and connection information, statistics on page views, traffic to and from the sites, ad data, IP address and standard web log information;
- 6. additional information to authenticate user(s);

- 7. information from other companies, such as demographic and navigation data; and
- 8. other supplemental information from third parties).

### **Marketing**

Happeningz.com does not sell or rent personal information to third parties for marketing purposes without explicit consent. Happeningz.com may combine information with data collected from other companies.

#### Use

Happeningz.com primary purpose in collecting personal information is to provide user(s) with a safe experience. User(s) agree that Happeningz.com may use personal information to:

- 1. provide the services and customer support;
- 2. customize, measure and improve services, content and advertising;
- 3. prevent potentially prohibited or illegal activities, and enforce the Happeningz.com User Agreement;
- 4. resolve disputes, collect fees;
- 5. inform user(s) about Happeningz.com services, targeted marketing, service updates, and promotional offers; and
- 6. compare information for accuracy.

## Happeningz.com and Disclosure of Information

Happeningz.com may disclose personal information to respond to legal requirements, enforce policies, respond to claims that specific content that may violate the rights of others, or protect anyone's rights, property, or safety. Such information will be disclosed in accordance with applicable federal and state laws and regulations.

Happeningz.com may also share personal information with:

- PayPal, Skype or other similar websites and services in order to help detect and prevent potentially illegal acts and violations of Happeningz.com policies and to guide decisions about products, services and related communications. Service providers under contract who help with our business operations (such as fraud investigations, bill collection, affiliate and rewards programs and co-branded credit cards).
- 2. Other third parties to whom user(s) explicitly ask Happeningz.com to send information.
- 3. Law enforcement or other governmental officials, in response to a verified request relating to a criminal investigation or alleged illegal activity. In such events, we will disclose information relevant to the investigation, such as name, city, state,

- zip code, telephone number, email address, User ID history, IP address, fraud complaints, and listing history.
- 4. Information Happeningz.com in its sole discretion believes necessary or appropriate in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity.
- 5. Other business entities, should Happeningz.com plan to merge with or be acquired by that business entity. Should such an event occur, Happeningz.com will require that the new combined entity follow this privacy policy with respect to personal information. If personal information is to be used contrary to this policy, user(s) will receive prior notice.)

Without limiting the above Happeningz.com will not otherwise disclose personal information to law enforcement, other government officials, or other third parties without a subpoena, court order or substantially similar legal procedure, except when in good faith that the disclosure of information is necessary to prevent imminent physical harm or financial loss or to report suspected illegal activity.

### **Information Shared by User(s)**

User IDs are displayed throughout Happeningz.com and are therefore, available to the public. Other user(s) can see purchases, items for sale, storefronts, feedback, and associated content. Notices sent to other community members about suspicious activity and policy violations may refer to User IDs and specific items. So if user(s) associate their legal names with their User ID, the people to whom you have revealed your name will be able to personally identify your activities.

If user(s) access Happeningz.com from a shared computer or a computer in an internet café or other similar venue, certain information about the user(s), such as your User ID, activity or reminders from Happeningz.com, may also be visible to other individuals who utilize that same computer.

## **Using Information from Happeningz.com**

Happeningz.com enables user(s) to share personal and financial information to complete transactions. Happeningz.com cannot guarantee the privacy or security of users' personal information and therefore strongly encourage user(s) to evaluate the privacy and security policies before entering into any transactions and sharing any information. Happeningz.com allows limited access to other users' contact, shipping and financial information to facilitate transactions. When users are involved in a transaction, they may have access to the following information: each other's name, User ID, email address and other contact and shipping information.

#### **Cookies**

Happeningz.com utilizes "cookies" on specific pages to help analyze web page flow; customize services, content and advertising; measure promotional effectiveness, and promote trust and safety.

A few important things user(s) should be aware of regarding the use of cookies is that:

- 5. User(s) may encounter cookies from third parties on certain pages of the sites that Happeningz.com does not control.

## Prohibited Spam, Spyware or Spoofing

Happeningz.com does not tolerate spam, spyware or spoofing on its sites of in relation to any of its services. user(s). User(s) may not use Happeningz.com communication tools to send spam or otherwise send content that would violate the Happeningz.com User Agreement.
