Happeningz.com User Agreement

ARTICLE I

Introduction to Happeningz.com

ARTICLE II

Scope of Use

ARTICLE III

Conditions of Using Happeningz.com

While using Happeningz.com sites, services and tools, you hereby agree and covenant not to:

Buyer Protection

Legal Disputes

- 1. Venue, Choice of Law and Forum for Legal Disputes This Agreement shall be governed in all respects by the laws of the State of Tennessee as they apply to agreements entered into and to be performed entirely within Tennessee between Tennessee residents, without regard to conflict of law provisions. User(s) agree that any claim or dispute against Happeningz.com must be resolved exclusively by a state or federal court located in Wilson County, Tn except as otherwise agreed by the parties or as described in the Arbitration Option paragraph below. You agree to submit to the personal jurisdiction of the courts located within Wilson County, Tennessee for the purpose of litigating all such claims or disputes.
- 2. Arbitration Option For any claim (excluding claims for injunctive or other equitable relief) where the total amount of the award sought is less than \$15,000, the party requesting relief may elect to resolve the dispute through binding non-appearance-based arbitration. In the event a party elects arbitration, they shall initiate such arbitration through an established alternative dispute resolution ("ADR") provider mutually agreed upon in advance in writing by all parties. The ADR provider and the parties must comply with the following rules: (a) the arbitration shall be conducted by telephone, online and/or be solely based on written submissions, the specific manner shall be chosen by the party initiating the arbitration; (b) the arbitration shall not involve any personal appearance by the parties or witnesses unless otherwise mutually agreed mutually agreed upon in advance in writing by all parties; and (c) any judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction.
- 3. Improperly Filed Claims All claims brought Happeningz.com must be resolved in accordance with this Legal Disputes Section.
